STRENGTHENING COMMUNITY VIA RESTORATIVE JUSTICE AS A PATHWAY TO PUBLIC SAFETY

Nehemiah Rising is in partnership with several organizations, including the Samuel DeWitt Proctor Conference, Advocate's Center for Faith & Community Health Transformation and the Chicago Mennonite Learning Center to completely overhaul and formalize restorative justice education, training and implementation strategies to assist community stakeholders in devising strategies to build restorative justice eco-systems particularly relevant for strengthening community capacity to ensure the safety of their specific community.

Beginning in January 2021 the roll out of the curriculum will take place with a cohort of community stakeholders, who will provide feedback and strategies for utilizing the methodology for building restorative justice ecosystems as appropriate within their own communities. The curriculum includes restorative justice philosophy and practices at the intersections of Identity, Faith, System/Structural Inequity, Trauma and Resilience, Systems Thinking, and Economic power building. The methodologies include community asset mapping, utilization of truth telling commissions and community organizing.
